

# YELLOW PINE ESCAPADE EVENT

## Event Rules

1. Helmets **MUST** be worn by all participants/riders who are less than 16 years old.
2. Vehicle drivers shall have a valid driver's license; under-aged, non-licensed drivers must have parental/guardian consent.
3. All traffic signs and road regulations shall be obeyed.
4. The event is not a race; drivers shall abide by the posted speed limit.
5. The event is a fund-raising event for the Yellow Pine Community Hall; all funds donated for participation will be used for this purpose.
6. A participant is a person who has donated to participate.
7. Participants under the legal age of majority **MUST** have parental/guardian consent to participate.
8. Consumption of alcoholic beverages by any participant/rider during the event is expressly forbidden.
9. The use of any narcotic or dangerous drug by any participant/rider is specifically prohibited.

## ACCIDENT WAIVER AND RELEASE OF LIABILITY

### READ CAREFULLY

I acknowledge that the Yellow Pine Escapade Event carries with it the potential for serious injury and even death. The risks include, but are not limited to, those caused by road surface, temperature, weather, condition of vehicles, vehicular traffic, actions of other people including but not limited to, participants, volunteers, spectators, wildlife, and lack of attention to driving.

I hereby agree to assume all the risks of participating in the Yellow Pine Escapade Event. I realize that liability may arise from negligence or carelessness on the part of the persons or entities being released, or because of their liability without fault. I certify that:

- I have sufficient training for participating;
- I am physically able to participate in the event;
- My vehicle is on the road legally; is in roadworthy condition; is being used by the participant with the owner's permission; and is covered by liability insurance.

I acknowledge that this Accident Waiver and Release of Liability form will be used by the Village of Yellow Pine Association and organizers of the event in which participate and that it will govern my actions and responsibilities at said event.

In consideration of my request and permitting me to participate in the Yellow Pine Escapade Event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assign as follows:

- A.** Waive, Release and Discharge from any and all liability for my death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me including attorney's fees, litigation costs, and my traveling to and from Village of Yellow Pine Association events, THE FOLLOWING ENTITIES OR PERSONS: all Local and State governments, the Boise National Forest Service, the Payette National Forest Service, and the Village of Yellow Pine Association, their officers, volunteers, representatives and agents, the event sponsors, event staff, event volunteers, and any affected property owners;
- B.** Indemnify and Hold Harmless the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in the Yellow Pine Escapade, whether caused by the negligence of myself or others.

I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident and/or illness during these events.

I understand that this event or related activities, and I may be photographed, videotaped, or have my likeness reproduced. I agree to allow my likeness to be used for any legitimate purpose by the event holders, producers, and/or organizers.

This Accident Waiver and Release of Liability shall be construed broadly to provide a release and waiver to the maximum permissible under applicable law.

I further agree to abide by all the rules as set forth by Yellow Pine Escapade Event directors.
